Evidence supported the defendant's convictions for felony murder based on kidnapping with bodily injury, aggravated assault with a deadly weapon, and possession of a firearm during the commission of a felony when the trial court did not err by denying the defendant's motion for directed verdict because the evidence that the victim was bound and gagged by the defendant, dragged from her house to the back of a car, thrown inside, and left for an extended period of time in the trunk was sufficient to support a finding by the jury that the defendant knowingly inflicted bodily injury on the victim in the commission of a kidnapping as required by O.C.G.A. 16-5-44(a); there was evidence that the defendant brandished a deadly weapon in the commission of an aggravated assault when the defendant beat the victim with a golf club and when the defendant threatened the victim with a handgun; and the victim's death was the proximate result of the defendant's acts. *Id.* Evidence that the defendant was a cellmate of another aggravated assault and burglary defendant at the time the defendant tried to sell his testimony on the first case of the same victim provided an additional basis for admitting

the evidence, including the evidence that the first defendant did not testify, of the other defendant's arrest and conviction of offenses against the same victim. The first defendant told the first investigating officer that he would testify that he did not participate in the armed robberies, but that a "man named John," not the defendant, committed the crimes. When later confronted with the testimony of this other defendant, the first defendant changed his story to deny that the man named John was his partner. Additionally, the first defendant told the investigator about a meeting he had with the police where, according to the defendant, the first investigating officer threatened the defendant with charges and promised the defendant that if the defendant testified in the other defendant's case, the defendant would receive leniency in his case and a recommendation for probation for all the cases in which the defendant had been convicted. The first defendant refused to testify but ultimately gave a statement in which he stated that he committed the armed robberies. The detective also testified that the first investigating officer had made a promise of leniency to the

defendant. During the defendant's cross-examination of the detective, the defendant was asked whether he was in a cell with the first defendant, and the defendant answered in the affirmative. After the detective further answered questions about the circumstances of the defendant's arrest and interrogation, the following colloquy occurred:
