[4] Subsequent to the filing of the original petition, the father filed a motion for pendente lite custody of the child and a Rule 12 motion to dismiss and requested an additional hearing on the custody issue. [5] The present record does not contain any written order granting such visitation. [6] The record does not disclose if the father is represented by counsel, although he was given the opportunity to be represented by counsel at the March 26, 2003, contempt hearing. [7] The record indicates that the father's counsel was

aware that the attorney for the child was appointed by the circuit court on January 28, 2003, and that he was also aware that the guardian ad litem for the child, whose testimony was that the mother was unfit to have custody of the child, was appointed on February 27, 2003. The record does not disclose the reason for these appointments. [8] The amended petition was filed with the clerk of the circuit court on March 3, 2003, which was subsequent to the order of the circuit court entered on February 4, 2003, which found the mother in

contempt. [9] The State of West Virginia, ex rel. Haydon v. Roane County Court of Common Pleas, 83 W.Va. 316, 328, 98 S.E. 329, 334 (1919) stated: We further find that the contempt was not committed on the highway. It was committed in a private home at which there was no highway. The act of disobedience was committed in the precincts of the respondent's own house. It was out of the presence of the court. It did not concern the charge or practice of the court. The contempt could not be committed on the highway or before the court or before any

other court. It could be committed only within the f988f36e3a
